## AVENUE WEST GALLERY RULES & INSTRUCTIONS

**ENTRY FEE:** \$10 PER ENTRY –LIMIT OF FIVE ENTRIES

**ELIGIBILITY:** This exhibit is open to all artists in the categories of PAINTING, which includes oil, watercolor and mixed media and PHOTOGRAPHY, both film and digital. There is a limit of five (5) entries. Work must be the original creation and composition of the artist submitting it. Copying a painting or photograph by another artist with a few details change is not considered an original work. Artwork must have been painted within the last two years. Student work that has been done in class or with the help of an instructor cannot be submitted. Current members of Avenue West Gallery are not eligible to enter this exhibition.

**JURYING:** Selection will be by digital imaging JPG format for inclusion in the exhibit. Artists, whose works are accepted, will ship or bring the original work for the judging of awards and inclusion in the exhibit to Avenue West Gallery, 122 S. Monroe St, Spokane, WA. Avenue West Gallery reserves the right to refuse any artwork that it deems improperly presented, unsafe, damaged, or not the same as represented in the digital image submitted for judging. NO withdrawals or substitutions will be accepted after a work is juried into the exhibit.

**ACCEPTANCE & NOTIFICATION:** All digital entries must be received no later than: **THURSDAY, MAY 20<sup>th</sup>**. Notification will be mailed to each entrant, no later than Friday, June 18th, 2010, indicating which works were accepted or declined. Avenue West Gallery is not responsible for lost, stolen, or misdirected entries. If an artist whose work has been accepted into the show fails to send that work for the Exhibition, that artist will not be permitted to enter any future AWG exhibits.

**DELIVERY OF ACCEPTED WORK:** All accepted artwork must be received at **Avenue West Gallery, 122 S. Monroe, Spokane WA 99201** between **Friday, July 23<sup>th</sup> & Friday, July 30<sup>th</sup>**. If works are shipped they must be shipped with return prepaid postage included.

**RETURN OF WORK:** Shipped work will be returned to the artist at the end of the exhibit beginning the week of **August 28<sup>th</sup>** and must have included prepaid return postage. **Work not shipped must be picked up from the gallery Saturday August 28<sup>th</sup> between the hours of 11am and 6pm.**

**LIABILITY:** Avenue West Gallery DOES NOT carry insurance on individual works. If you wish to have your work insured, you must make your own arrangements, including coverage during transit.

**DIGITAL ENTRIES:** Each artist may submit five (5) entries. Digital entry files must be in JPEG format on a CD (compact disc). Submit one image per entry with a minimum resolution of 640x480. More than one entry may be on your CD. The image must be oriented correctly (vertical or horizontal). Title the image file: artist first initial, last name, first two words of title.jpg Example: JSmithWoodScene.jpg  
Do not use spaces or punctuation except .jpg at end. Label your CD using a permanent marker, with your name and phone number. The CD will not be returned. **DO NOT SEND ORIGINALS!**

**SIZE REQUIREMENTS OF ENTRIES:** Maximum framed size: perimeter must not exceed 140" (the total inches of each side added together). Works that do not meet the size specification will be disqualified, even if initially accepted. All work must be framed and ready to hang. No sawtooth or alligator hangers, please! You must have an identification card on the back of each piece with your name, phone number, title of piece and sales price.

**ARTWORK SALES:** If artwork is sold during the duration of the exhibit, Avenue West Gallery will retain 30% of the sale price, excluding sales tax. State sales tax of 8.7% will be added onto the sale price at the time of sale. Sales will be processed through Avenue West Gallery and checks for sales will be mailed to all artists at the conclusion of the exhibition.
